### **INSTRUCTIONS FOR USE OF COUPON 5E - FORM 1027**

FORM 1027 -- "APPLICATION FOR AUTOMATIC EXTENSION OF TIME TO FILE DELAWARE INDIVIDUAL INCOME TAX RETURN", THE COUPON NUMBERED 5E (FRONT OF THE FORM) IS ONLY TO BE USED TO REQUEST AN EXTENSION OF TIME TO FILE YOUR DELAWARE INDIVIDUAL INCOME TAX RETURN FOR THE TAXABLE YEAR SHOWN ON THE COUPON. DO NOT SUBMIT AN ESTIMATED QUARTERLY TAX PAYMENT ON COUPON 5E SINCE SUCH USE WILL RESULT IN INCORRECT RECORDING OF YOUR PAYMENT AND A DELAY IN THE PROCESSING OF YOUR FINAL DELAWARE INDIVIDUAL INCOME TAX RETURN FOR THE YEAR AFFECTED. IF YOU LOSE YOUR DECLARATION OF ESTIMATED TAX COUPONS (FORM 200-ES) OR DO NOT RECEIVE NEXT YEAR'S PACKAGE BY FEBRUARY 15, PHONE THE DIVISION OF REVENUE'S PUBLIC SERVICE BUREAU AT (302) 577-8200 FOR REPLACEMENT FORMS.
